SPACE RENTAL APPLICATION REQUIREMENTS

We welcome non-profit information tables and vendors selling items of interest to our community. To ensure an enjoyable day, please follow the guidelines listed below:

- Show support of our Gay, Lesbian, Bisexual and Transgender theme.
- Each organization, or business will be assigned a location based on the date GALA received payment. Vendors will be directed to their space on the morning of the event.
- The City of San Luis Obispo requires a Vendor Fee of \$20.00 for vendors that are selling items at the event, in addition to the space rental cost. If you already have a business license with the city of San Luis Obispo, please enclose a copy of your license with your application and the fee will be waived.
- GALA cannot grant exclusive rights limiting the selling of merchandise, or food items.
- Display set up time is 8:00 a.m. and must be completed by 11:30 a.m. - NO EXCEPTIONS
- All Vendors must provide their own tables, chairs, canopy, etc. Most rental companies are closed on Sundays in San Luis Obispo.
- If selling, enclose a copy of your Business License with your application.
- Vendors are responsible for their own insurance.
- No alcohol sales are permitted under this application.
- Vendor applications are subject to approval by GALA's "Pride in the Plaza" Committee.
- **NO REFUNDS once your application has been RECEIVED and ACCEPTED for the event.**
- **Event will be held, rain or shine, NO REFUNDS, so please be prepared!**
- **LIABILITY INSURANCE. All Exhibitors must submit a valid certificate of insurance** with liability limits of at least \$1,000,000 naming both GALA and the City of San Luis Obispo as additionally insured. If you do not have insurance capable of providing this, there are companies that provide daily vendor insurance. You can find such companies by searching for "daily vendor insurance" on the WEB. An example of such a company is Shahinian Insurance Services, Inc. at 800-457-2231 or on the WEB at www.shahinianinsurance.com.

- All applicants must adhere to County Health Department Regulations in preparation and serving of food.
- Any vendor that will be cooking or producing heat must supply a fire extinguisher for the booth space (code 2A-10BC).
- All trash must be compacted and disposed of in a dumpster at the close of the event.
- NO glass containers may be sold.
